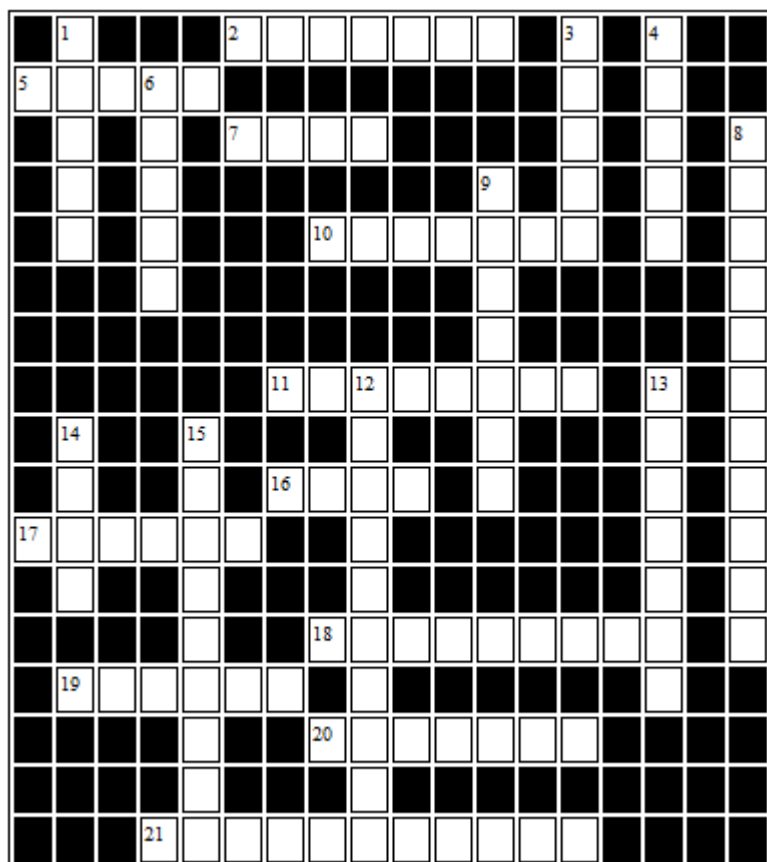


## ESERCIZIO “RILASSANTE” SUL CONTRATTO DI FORNITURA

THE PARTIES AGREE AS (2o)\_\_\_\_\_:

-That the custom duty, VAT or other Taxes and cost of transportation, or any other incidental charges, if required in connection of the delivery of goods shall be (1v)\_\_\_\_\_ by THE SUPPLIER.

-That if THE SUPPLIER shall in any manner neglect or fail to carry on the work or (8v)\_\_\_\_\_ of the terms of the Agreement with due (15v)\_\_\_\_\_ or violates any of the (3v)\_\_\_\_\_ of (14)\_\_\_\_\_ Agreement THE PURCHASER shall be entitled to (18o)\_\_\_\_\_ The Agreement and demand (13)\_\_\_\_\_.

-That if any (20o)\_\_\_\_\_ arises in connection with or under this Agreement between the Parties (19o)\_\_\_\_\_, the matter shall be referred to the (5o)\_\_\_\_\_ of Sussex or designate and the (11o)\_\_\_\_\_ of the Court of Sussex shall be final, conclusive and (9v)\_\_\_\_\_ upon both the parties.

-That THE PURCHASER reserves the (6v)\_\_\_\_\_ to change their specified delivery site for any reasonable ground or grounds and the THE SUPPLIER shall be (17o)\_\_\_\_\_ to deliver the materials at the new site. The transportation cost for delivery at the new site will be decided by both the (10o)\_\_\_\_\_.
